A LEAP TOWARDS PROPSEROUS PAKISTAN



Salient features of proposed Economic Reform Package (ERP) presented by Minister Finance Asad Umer on January 23, 2019:

- To reduce tax from 39% to 20% on income generated from loans to small businesses, agriculture sector and low-income housing.
- To introduce interest-free revolving credit of Rs.5 billion (qarz-i-husna).
- To waive off withholding tax on bank transactions for tax filers.
- To relax restriction for non-filers on purchase of locally manufactured motor vehicles up to 1300CC and to relax restriction purchase of immovable property as well as locally manufactured vehicles for non-resident Pakistani citizens.
- To exempt small businesses from submitting withholding tax returns every month; will submit only twice every year.
- To reduce fixed tax on marriage halls from Rs.20,000 to Rs.5,000.
- To completely abolish duty on newsprint.
- To exempt investment in solar panels and wind turbines from duties and taxation for five years.
- To reduce and abolish (in some cases) duties on raw materials for supporting export-oriented industries.
- To abolish Super Tax on non-banking companies from July 1, 2019.
- To continue 1% per annum reduction in corporate income tax.
- To allow capital loss carry-over for 3 years (stock trading).
- To abolish 0.02% withholding tax on trading.
- Taxes and duties on mobile phones rationalised: taxes on budget sets to be reduced, high-end sets to become more expensive.
- To exempt machinery for greenfield projects (including renewables) from customs duty, sales tax and income tax for five years.
- Tax refunds to be worked out; promissory notes to be issued by mid-February.
- Gas Infrastructure Development Cess to be removed from fertiliser production.
- To reduce duty on diesel engines for agricultural applications to 5% from current 17%.

GOVERNMENT REVOLUTIONIZES VISA RULES TO REVIVE TOURISM IN PAKISTAN

Pakistan introduces new revolutionary visa policy to encourage tourism in the country through following steps:

- The Government is offering visas on arrival to visitors from 50 countries and electronic visas to 175 nationalities.
- Pakistani government wants tourism to become the foundation for change in Pakistan.
- Pakistan has immense opportunities in mountain tourism, religious tourism, beach tourism, cities and food tourism.
- Tourists would be allowed to visit the politically sensitive Himalayan region of Kashmir and other northern areas, which require special permission.
- All concerned agencies and departments are directed to facilitate tourists and streamline their procedures to fulfil the Prime Minister's vision of making Pakistan a tourist destination.
- Visa on arrival will also be provided to Indian-origin British and American citizens holding passports of United States or United Kingdom.
- Tour operators that are approved by the International Air Transport Association (IATA) will now be allowed to bring groups of tourists to Pakistan.
- Additionally, the process for acquiring work visa for the nationals of 96 countries for business purposes has been eased.
- Applicants will receive their visa in 7-10 days after the Board of Investment issues them a letter.
- The duration of diplomatic and student visas has also been extended.
- The processing of journalist visas will be done through the Information Ministry and restrictions on journalists to limit their movements to just three cities have been lifted.
- Foreign tourists do not need NOC anymore to visit open cantonments, Azad Jammu and Kashmir, and Gilgit Baltistan.

In an exclusive interview with PBIT's Marketing team, Shoaib Zahid Malik described strong economy as "the highway" to the development and sustainability. He spoke on a wide range of topics from telling more about himself, his opinion about the challenges faced by investors and how to address these challenges and explained his approach to attain economic sustainability.

Q: PLEASE TELL US ABOUT YOURSELF, YOUR BUSINESS EXPERIENCE AND HOW LONG HAVE YOU BEEN IN THIS SECTOR.

"I am a business aficionado for more than 20 years, I came from a 3rdgeneration family business in Pakistan, KAUSAR Group of Companies (kausar.com.pk) established in 1951 by my late grandfather. Kausar Group is a leading manufacturer and processors of various edible products such as

basmati rice, cooking oils, vegetable meals, banaspati ghee, poultry feeds and broiler chicken.

My passion and dream is to transform businesses into institutions that contribute to the wellbeing of the society. As the Chairman of PIEDMC, my vision is to lead the company in a dynamic and innovative manner by capitalizing on its strengths.

The newly appointed Board of Directors of PIEDMC is comprised of young entrepreneurs, industrialists, educationists and leaders in their industries. They bring forward the vision of our Prime Minister to make Pakistan a flourishing economy. Q:In your opinion what are the key Challenges/ impediments IT/Business Process Outlook face in Pakistan and in Punjab in particular?

"On a macro level, lack of collective wisdom has hampered growth in Pakistan. On a more micro level energy provision is one of the most

challenging issues right now.. Inadequate supply of skilled & trained labor force, poor infrastructure and cumbersome procedures are some of the key stumbling blocks that impede industrialization

Q:What are the key initiatives the Government can take to support this sector?

a. Short term i.e 4 months – 6 months

In my opinion, declaration of SEZ status for Bhalwal, Rahimyar Khan and Vehari Industrial Estate, improve colonization of existing industrial estates, improve services in existing industrial estates, sway on alternate & renewable energy, power plants on PPP mode, Initiate development of QAAP & Bahawalpur Industrial Estate, grant of license from NEPRA for electricity. Ease of doing business and a more efficient one window service center can bring in changes.

b. Mid-term i.e. 6 months to 2 years

Institutional and governance reforms for improved Industrial Estates, reform process of doing business i.e ease of registration & entry, time bonded approvals, compliance of Industrial Units with regulation & Standards, Improve connectivity of existing Industrial Estates improve working of BOM's and monitor their financial transactions. Combined Effluent Treatment Plant (CETP)'s on PPP mode are required support by the Government.

c. Long term i.e 2 years to 5 years

In long term, the government should Increase the share of Manufacturing in the industrial sector by working on sector specific policies/incentives green industrial parks by reducing pollution & water conservation, availability of skilled workforce in collaboration with TEVTA & PSDF, Safe City Concept for Industrial Estates, Up-gradation of existing Industrial Clusters with the help of IC&ID and public governing bodies, and to devise a framework/ policy to encourage private industrial estates.

Q: What legislative/ regulatory changes can the govt. do to support this sector?

PIEDMC should be made an authority/ regulatory body having representation from Public & Private sector in its BOD. Arrangements should be made to get licenses from NEPRA, encourage industries only inside industrial estates and devise legal framework for additional tax incentives for industries setting up their units within industrial estates in addition to incentives announced by the federal & provincial government.

Falahat is a proactive and talented business woman with great ideas and aspirations, all of which aim towards a better Pakistan. She is persistent to make a dynamic change for the women of our nation.

Q: WHAT INSPIRED YOU TO BE AN ENTREPRENEUR?

My passion for art and design, love to modify and make things beautiful pushed me to start my business of printing and publishing named Printshop. The skill development diploma in graphic design from NCA helped me to generate the idea of setting up my printing unit where I could utilize my passion in a productive way. Being an entrepreneur takes an incredible amount of work that involves being responsible for everything from the initial concept, branding, growth and eventually goal setting. When you are able to make a comfortable living doing what you love, it's a win-win situation.

Q: As a woman how helpful did you find your surroundings in starting your own work?

A woman has to perform various roles either familial or social, regardless of her career as working woman or an entrepreneur. Being a woman, we are expected to play a larger part in handling household and taking care of the

family responsibilities whereas running a business means devoting your time to work as well. Balancing between the two is quite tough at times. When a woman begins an entrepreneurial venture, much support is needed to set up her place in the existing business environment but the minimal support often distracts her from reaching her destination. Obviously the surroundings have not been so supportive, but gradually things become better once one makes the decision to pursue ones dreams.

Q:WHAT WERE THE MAIN CHALLENGES YOU FACED?

Women seem to be ruling the world at the moment and have established an upright image of themselves as outstanding workers in all fields such as teaching, pharmaceuticals, I.T., media, public sector, hospitals, opening up new boutiques and beauty parlors and working in different NGOs as well. Despite the fact that they are emerging in all industries they still are faced with multiple challenges and obstacles in this male dominated society.

Balancing personal and professional life is the most common difficulty that every woman faces when stepping out to enter a career. Performing dual duties of both household and professional is in itself a huge task so I really try hard to manage both my responsibilities with complete devotion and commitment.

Q: As WCCI'S PRESIDENT WHAT WERE YOUR OBJECTIVES TO FACILITATE WOMEN ENTREPRENEURS?

Associated with Women Chamber of Commerce and Industry (WCCI) as its President had been an honor for me. My objectives was to facilitate and encourage women entrepreneurs with an effort to ensure their positive contribution in the economic growth of Pakistan. The export of knitwear from the country increased by 10.58 percent to \$1.21 billion during July-November 2018-19 against the export worth of \$1.1 billion during same period of previous year. In terms of quantity, the export of knitwear witnessed a surge of 20.24 percent as it rose to 52.17 million dozens of knitwear in first five months of current fiscal year against the export of 43.4 million dozens in same period of the year 2017-18, says a latest data released by Pakistan Bureau of Statistics (PBS).
